# TO ALL MEMBERS<sup>1</sup> OF THE DESJARDINS GROUP PENSION PLAN (QPP Registration Number: 25717)

May 31, 2006

The Annual Meeting of Members of the Desjardins Group Pension Plan was held on March 24 at the Centre des congrès in Quebec City, as part of Desjardins Group's Annual Meetings.

After welcoming everyone present, the Chair of the Desjardins Group Retirement Committee, Mr. Denis Paré reminded attendants that the purpose of the elections was to fill a position to represent active members from the Desjardins caisses. He announced that Mr. Michel Michaud, General Manager of the Caisse populaire St-Charles sur le Richelieu, was reelected by acclamation, to represent active members from the Desjardins caisse network.

The Chair started his message by mentioning that the year 2005 had been exceptional for the Plan, which posted an overall return of 14.4%, placing it in the top quartile in the pension plan industry, specifically 18<sup>th</sup> percentile. This is the Plan's highest ranked performance in its history. Its return exceeded the median of Canadian pension funds by 2%, which represents an added value of \$84 million.

He went on with a presentation of the financial results of the Plan, the highlights from 2005, the amendments to the Plan Regulation in 2005. He also informed those present that the Retirement Committee had adopted a 2006-2008 strategic plan in line with that of Desjardins Group, and he presented the issues and objectives.

Mr. Paré then thanked the following people, who left the Retirement Committee this past year, for their contribution: Ms. Madeleine Lapierre, Chair, who retired in April 2005, and Mr. Edgar Joly, representative for the affiliated corporations. He also welcomed two new committee members, Mr. Pierre Grenon, representative of employers, and Mr. Simon Garneau, representative of active members from the affiliated corporations. The Chair concluded by thanking committee members for their attention and availability in the past year. He also thanked Ms. Monique Leroux, Mr. Raymond Laurin and their team in the Desjardins Pension Plan Executive Department for their exceptional support and hard work that led to such impressive results.
